



Austin Convention Center LEED Consulting-Pursuing Gold Certification Austin, Texas

Since 2009, FEA has been working with the Austin Convention Center (ACC) to achieve LEED for Existing Buildings certification. At the beginning of the project, the convention center had several sustainability measures in place. FEA partnered with ACC to build on and improve the convention center's overall performance with a seven step strategic plan:

1. **Quality Control Plan** – FEA documented quality control and communication protocol governing the project.
2. **Strategic Plan Assessments** – What level of certification is achievable? What will the effort be and how much will it cost? FEA helped answer these questions by performing an assessment of current status, operational policies and practices, and potential for improvement.
3. **Strategic Plan Development** – Following the Strategic Plan Assessments, FEA worked with Austin to determine what credits would be pursued and provided prioritized recommendations tailored for ACC.
4. **Plan Implementation** – FEA is in the process of working with ACC to implement projects required to meet the prerequisites and selected credits.
5. **Commissioning** – FEA is completing a comprehensive retro-commissioning of the convention center's air HVAC, exhaust, lighting, and building controls systems. As part of this effort, the ACC/FEA team developed a Building Operations Plan which documents operational intent, system capabilities, and performance criteria. During retro-commissioning, FEA documented deficiencies and recommendations for repairs, as well as opportunities to enhance performance and efficiency.
6. **Documentation Preparation** – FEA guided the project team through the LEED documentation process for submission to the USGBC including document assembly and upload to the USGBC's LEED Online web-based tool.
7. **Final Certification Report** – FEA prepared a comprehensive certification report containing all submitted documentation. This will assist the City of Austin with future certification and guide future sustainability efforts.

The project was awarded LEED Gold certification in December of 2011.
